One or more petitions may be circulated and one or more petitions filed on behalf of Candidate(s) providing:

1. Read petition carefully and fill in all the information where required.
2. The petition must be signed by legally qualified voters residing in the County of Morris if the petition is for a County Office and/or in the municipality or ward of the municipality if the petition is for a Municipal and/or Ward Office. The petition must be signed by at least 2% of the legally qualified voters of the entire vote cast for Members of the General Assembly at the last preceding General Election for which nominations for the General Assembly were made in the County in the case of County Officers or in the Municipality and/or Ward in the case of Municipal and/or Ward Offices provided that no more than 100 signers are required in any case.
3. That in aggregate the number of valid signers of the petition(s) equal or exceed the number required by law.
4. The person in whose presence the petition was signed must make the affidavit before an officer authorized by law to take affidavits.
5. That the candidate(s) endorsed in the petition fully complete and execute the Oath of Allegiance (page 17) before a notary or other officer authorized to take oaths and they also must sign the Certificate of Acceptance stating that he/she is qualified for the office.
